

Since 2009, the Guilderland Police Department has been an accredited agency through the New York State Law Enforcement Accreditation Program. Being an accredited agency is something that the department is proud of as only approximately one third of agencies across the state are accredited. The agency works tirelessly to comply with the State's 111 standards to ensure that the agency is partaking in best contemporary practices and operating on sound policy in order to best serve the public. The New York State Division of Criminal Justice Services describes the accreditation program as:

*Voluntary and designed to improve an agency’s effectiveness, efficiency and professionalism; promote training and foster public confidence in law enforcement. Agencies must meet a set of standards in three categories: Administration, Training and Operations. Accreditation provides formal recognition that an agency meets or exceeds expectations of quality;*

The reaccreditation process occurs every five years and the agency is due to be reaccredited in 2024. The agency utilizes sworn personnel to maintain the accreditation program. Sergeant Egnor is the Program Manager and Patrolman McCormick is the Assistant Program Manager.

TRAINING

The highlight of training for 2023 was scenario-based training for response to an active attack conducted at the Guiderland High School in the spring. A large part of the training was

a walk-through of the school and “dry runs” where officers were sent to mock calls for service in several different locations within the school. This allowed our newer officers to become intimately familiar with the lay out of the school and the locations of different classrooms, gyms, exterior doors etc. Then the officers conducted live active attack scenarios utilizing role players and simunition firearms. This training, along with our officers consistently participating with lockdown drills, and conducting walk-throughs of all schools in the district enhances our ability to respond to an emergency quickly and effectively.

The Guiderland Police Department in partnership with the Guiderland Central School District added a second school resource officer. Officer Kris Scarano attended the Basic School Resource Officer School and the Basic Juvenile Officer School conducted by the New York State Department of Criminal Justice Services and the State of New York Police Juvenile Officers Association, respectively. Officer Scarano is assigned to Farnsworth Middle School.

Several officers participated in training for the detection and apprehension of driving while ability impaired by drugs in an effort to target impaired drivers and keep our roadways safe. Also in 2023, the department added an additional officer trained in the instruction of Procedural Justice to enhance positive interactions with the community and two officers were sent to Rape Aggression Defense instructor school to assist our department with hosting more R.A.D. classes for the community. Additionally, the notification of the death of a loved one can be one of the most traumatic experiences in a person’s life. Due to the sensitivity of this situation, 14 officers received training in the proper handling of the delivery of a death notification. These officers will be called upon to handle these difficult situations. Finally, all officers participated in mandatory annual training in the use of firearms, use of force, use of less lethal weapons, and legal updates.

## COMMUNICATIONS



The Guiderland Police Communications Division is staffed with certified E 911 telecommunicators. Enhanced 911 means that when you call 911, the address you are calling from is automatically displayed on the Telecommunicators screen. This is crucial in the event a person becomes unconscious before giving you the location or a crime in progress prevents the caller from giving the address. The Division is a 24-hour operation and is a vital link to the residents and businesses in this town to the emergency personnel in the field.

Currently, the communications division is staffed with 10 telecommunicators and 2 supervisors. Each telecommunicator is trained in Emergency Medical Dispatch (EMD), CPR and AED. Every two years, they recertify to keep up with their training in those fields. We are currently in the process of upgrading EMD to the computer version called PROQA. National Telecommunicators Week is recognized every year during the second week of April.

Communities and emergency communications centers honor those telecommunicators that help save lives in times of personal or a national crisis. New York State continues to recognize telecommunicators as First Responders.

As well as dispatching for the Guiderland Police department, the communications division also dispatch for the Altamont Police, Guiderland EMS and the 8 volunteer fire departments protecting our town. The division also has the capability to monitor and communicate with each of the 7 schools as well as the town parks, water, seniors and highway departments.

This year Telecommunicators received over 35,000 911 calls for service. Those 911 calls include, non-emergency calls and transferred cellular 911 calls. 25,908 calls were taken for police, 7,978 emergency medical services (EMS), and fire calls were received for service. This brings the total to 33,886 calls for service this year.

This year the Guiderland Police Communications division upgraded our radio consoles to a Motorola MCC 7500E Elite Digital Radio System. This upgrade enables us to be on the core with the Town of Colonie, City of Albany, and the counties of Albany, Schenectady, Saratoga and

Rensselaer, providing seamless interoperability and enhanced functionality. The system employs the latest radio technology and has proven to be a great public safety asset allowing radio interoperability amongst all agencies that once all operated independently.



Guilderland Police Communications has recently enabled RapidSOS, a solution that provides life-saving data - including caller location, health and medical information, connected building and alarm data, vehicle telematics data, and more – to our 911 telecommunicators and first responders in

the event of an emergency. With this upgrade, our telecommunicators can access accurate caller location and additional life-saving information when responding to 911 calls. This may include emergency contact information, security system alarm information, medical and health information, and more.

Guilderland residents can also become RapidSOS Ready by creating a free Emergency Health Profile at [www.emergencyprofile.org](http://www.emergencyprofile.org). By doing so, they provide first responders with critical medical information in an emergency to get you the right care at the right time.



**PREPARED**

In 2023 we also started utilizing Prepared Live which is a platform that allows users to text and livestream with a Guilderland Police Telecommunicator in an emergency. After you dial 911, a telecommunicator may text you a link to Prepared Live. This link is

what enables users to share your location and livestream from your mobile device. By sharing this information, Guilderland field responders can get eyes-on-scene quicker and deliver faster, better aid.

By doing so, they provide first responders with critical medical information in an emergency to get you the right care at the right time.

## PATROL

In 2023, our department welcomed seven new officers, all of which were lateral transfers from other departments. These officers replaced officers that retired or left the department as well as back-filled positions that were created to enhance the service that the police department is able to provide.

Positions such as a second school resource officer position and a fifth patrol supervisor position. The addition of these officers brought the total patrol staffing level to 25 Patrol Officers and 5 Patrol Supervisors.

This year the patrol division responded to 25,908 calls for service. Some

notable calls for service include an incident at the Homewood Suites on Western Avenue near Crossgates Mall in which an individual was firing a handgun from his hotel room into the hallway, into adjacent rooms, and out of the window. Due to the professional response of our patrol officers and with the assistance of partner agencies, this incident was resolved safely with no injuries sustained. The incident resulted in the arrest of that individual. Another

incident of note was a call at the Brandywine Park Apartments on State Farm Road in which a report was received that an individual stabbed his mother and brother. Again, because of the professional and efficient response of the Patrol division, rendering aid to the victims leading them to

a full recovery and isolating the threat, this incident was resolved peacefully and resulted in the arrest of the suspect. Additionally, our patrol officers responded to several medical related calls for opioid overdoses and cardiac arrests. Our officers are trained in the use of Narcan and CPR as well as various types of emergency medical care and maintain a strong

partnership with Guilderland Emergency Medical Services. In two instances, CPR provided by patrol officers assisted in the reversal of a cardiac arrest. Patrol also responded to 10 opioid overdose calls, 3 of which Narcan was administered by patrol officers which resulted in the person surviving the overdose.



**UPGRADED CAMERA SYSTEMS**

The Guilderland Police Department has been taking decisive and progressive steps towards building community trust through the use of body worn and in-car cameras. In 2017, the Guilderland Police Department implemented the use of Coban’s body worn cameras and in-car camera systems. The body worn cameras have proved to be a useful tool as they accurately capture uniformed police-community member interactions. The footage captured assists with processing evidence and aids in providing transparency. Video captured by an officer’s body-worn camera helps corroborate the facts of an encounter and results in quicker resolutions.

In the beginning of 2023, the Guilderland Police Department implemented the use of AXON body-worn cameras and in-car video systems. Members of the department have found the AXON cameras to be an extremely helpful tool. It has strong video/audio quality, along with its upgraded technology and system capabilities. Some of the capabilities include an embedded GPS, LTE Connectivity, LCD display, and a multicam playback. Each body worn camera that is in the vicinity where a patrol vehicle’s emergency lights have been activated, the body worn camera will activate as well. Thus, making it touch free for responding back-up officers when they arrive at a scene. The AXON camera also has the capability of taking still photos of a scene. AXON data is stored in a secured

proprietary cloud. Officers can access the data via a web-based platform which allows them to review and categorize body camera footage accordingly.

AXON pairs with Android and iOS devices, which empowers officers to utilize the AXON mobile application. This capability allows officers to categorize their cameras immediately following an incident. The application also allows officers to capture accurate recordings of incidents and interviews. Officers can also utilize the application to upload any evidence that may have been captured by the AXON camera.



AXON cameras that have been installed in all patrol vehicles add a new level of police transparency. The viewer of any in-car footage has a clear view of not only the holding compartment, but of what the operator of the vehicle sees through the windshield as well. This footage not only aids in building and keeping public trust, but is also a useful tool in addressing the rare occasion of a citizen complaint. From an investigative standpoint, if an arrested or

detained individual makes a spontaneous oral admission, their words are clearly recorded and may aid in completing a case. Having these cameras benefits not only the officers, supervisors, and administrators, but the public as well.

Not only do the AXON cameras function to capture footage, they also function as Automatic License Plate Readers (ALPR). The ALPR system covers a 60-degree field of view that covers three lanes of traffic—reading all plates passing each patrol

vehicle. This provides a high-quality, real-time, in-vehicle alert on plates of interest. This capability has been a successful tool with investigations and traffic enforcement.

Having access to all body camera footage of an incident allows for officers to debrief themselves in an informal setting. Seeing an incident that an officer responded to from multiple perspectives allows for that officer to review techniques or catch statements made by suspects that they may have initially missed. As we come together in the spirit of improvement, this footage can be a powerful learning tool.



## TRAFFIC SAFETY

One of the most important and daily duties of the Guiderland Police Department is traffic related concerns and enforcement. The Guiderland Police Department is dedicated to keeping our roads safe through the enforcement of the Vehicle and Traffic laws as well as deterrence and public education efforts. In 2023 members of the Guiderland Police Department conducted 3,354 vehicle stops which resulted in 1,640 issued traffic citations. These vehicle stops also yielded 55 DWI arrests. These traffic citations and arrests are due to the dedication of the officers. Officers issue far more warnings to drivers than traffic citations. It is the goal of the Guiderland Police Department to have the safest roads possible.

The Traffic Safety Unit is actively involved in the Albany County Stop DWI program, and through state sided funding The Guiderland Police Department also participates in Buckle Up New York, Operation Safe Stop Education and

In 2023 members of the Guiderland Police Department conducted 3,354 vehicle stops which resulted in 1,640 issued traffic citations. These vehicle stops also yielded 55 DWI arrests.

Enforcement Day, No Empty Chair, and the STEP (Selective Traffic Enforcement Program) which is the aggressive enforcement of such violations as aggressive driving, speeding, and driver distraction such as cellular phone use. The Guiderland Police Department continues to partner with the Guiderland Central School District for Operation Safe Stop. During this period in April, a display of a police car, school bus, and a message sign reminds motorists of the dangers of passing stopped school buses. The Traffic Safety Unit also uses portable traffic speed signs to assist with monitoring vehicles and their speeds on town roadways. These signs assist the traffic unit with the trouble areas and




*Portable Traffic safety sign*

determining when to have more patrols in the area for speed issues. The signs are portable and can be moved from place to place throughout the town. The town also received four additional permanent traffic signs that have been placed in different areas of the town.

Accident investigations and reconstructions are also conducted by members of the Guilderland Police Department Traffic Safety Unit. These officers are highly trained in accident reconstruction and utilize a

Total Station. The Total Station provides detailed measurements, resulting in exact accident reconstructions. This tool is used in serious personal injury and fatal motor vehicle accidents. In 2023 there was 1 fatal motor vehicle accident in Guilderland. In 2023 officers responded to 1,068 property damage accidents, 64 personal injury accidents, and 63 unknown motor vehicle accidents.

## COMMUNITY SERVICE UNIT

Members of the Community Service Unit enjoy interaction with the public and residents of the Town of Guilderland. In December, the Community Service Unit partnered with Dick’s Sporting Goods in Crossgates Mall for “Shop with a Cop” with the assistance of Pai’s TAE Kwon Do, the Guilderland PTA and the Guilderland PBA. Officers were able to share time with children from the town and spend \$200.00 on each of them due to generous donations by the groups above.

The Guilderland Police Community Service Unit (CSU) is staffed with a full-time officer, two school resource officers (SRO) and an investigator that splits his time between the CIU and CSU. All officers are certified juvenile officers that have extensive training in juvenile law, sexual/child abuse and missing persons investigations.

In addition, the officers provide the Guilderland School District with Drug Abuse Resistance Education (D.A.R.E.) and various instruction on topics like health, forensics and public policy. The CSU assists the patrol division with juvenile related offenses and



felony juvenile cases. The CSU works to identify and resolve community problems through proven law enforcement programs such as Rape Aggression Defense Program (R.A.D.), Drug Take Back Day and Coffee with a Cop. The CSU participates in community partnership events like local food drives and Dick’s Sporting Goods Shop with a Cop. The CSU gives presentations to senior citizens on fraud prevention, provides Civilian Response to Active Shooter Events (C.R.A.S.E.) training and installs child car seats by appointment. The CSU coordinates the set-up of National Night Out, special events, and provides an educational display at the Altamont Fair.

Officers in the CSU attend trainings related to forensic interviewing of children, missing children and child abuse.

The CSU oversees the Guilderland Explorer Post, which entered its 31st year. The Explorer program is a career-oriented program that allows the youth of our community between the ages of 14-21 an opportunity to explore law enforcement by working closely with members of the Guilderland Police Department. The post meets twice a month for training and provides assistance with community programs sponsored by the CSU. During the year, explorers receive training in police exercises and compete with other area posts. The training provides

Explorers with skills they will use in the future as potential police officer candidates, community leaders and over the summer at the Explorer Academy in Connecticut. The Explorer Academy is a weeklong multi-phased police academy where Explorers work alongside and compete against regional explorer programs. The Explorer program has been a valuable tool to reach out to and work with the youth of our community.






Officer Stevens has been a member of the department since August 2006, and became the K-9 handler in 2021 with the addition of K-9 Boreas to the unit. Boreas is a 3.5 year old German Shepherd who is a dual purpose canine, meaning he is Patrol certified in Tracking, Article searches and Handler Protection/Criminal Apprehension along with being certified in Explosive Detection.


Officer Stevens and K-9 Boreas attended and completed several outside training courses and seminars from world class and nationally recognized trainers, along with seminars and training events put on by the NYS Department of Homeland Security and Emergency Services and the FBI. The Canine Team train regularly with the Capital District Canine Training Group to stay proficient and up to date with certifications along with being afforded the opportunity to train in a number of environments and situations.

Officer Stevens and K-9 Boreas assisted the Guiderland Police Department, community and outside agencies with callouts for service including search warrants, bomb threats, scene security, tracking, missing persons, suspicious items and packages, crimes in progress along with other investigations.

The K-9 Team enjoy doing their work, but also take time to speak to members of the community including GCSD school events, D.A.R.E. graduations, the Altamont Fair, National Night Out, Crossgates Mall, and other community events.

## RETAIL INTERDICTION DETAIL

In 2023, RID Investigators handled approximately 1,892 documented calls for service. In 2023, there were a total of 185 adult arrests made at Crossgates Mall, 145 of those arrests were made by the RID Investigators. Additionally, RID Investigators were responsible for making 21 arrests that involved juveniles.

The town of Guilderland is home to the 5th largest shopping mall in New York State, Crossgates Mall. The Guilderland Police Department maintains a substation in the mall for handling complaints and arrests at the mall and on the eastern end of town. In 2018, the department initiated the Retail Interdiction Detail (RID) at the mall in anticipation of the holiday shopping season and due to several instances of public disorder. The detail is composed of two uniformed “RID” Investigators that are assigned there. The officers work “flex shifts” that coincide with the mall’s hours of operation. RID Investigators address issues related to theft from stores as well as disruptive or other criminal behavior that takes place within the mall. The RID Investigators team up with Crossgates Mall Security and Management, as well as loss prevention personnel from various stores to form a unified effort in reducing

thefts. In 2021, the mall welcomed Albany 518 Snug to its anti-crime efforts and those efforts continued through 2023. Albany 518 Snug deploys outreach workers in the mall to assist with identifying and interrupting potentially violent situations. RID Investigators share information with other law enforcement agencies in the area and the Capital Region Crime Analysis Center in regards to shoplifting incidents and arrests. Furthermore, they have played a vital role in identifying repeat shoplifters and identifying key players in retail theft rings in the area. In 2023, RID Investigators handled approximately 1,892 documented calls for service. In 2023, there were a total of 185 adult arrests made at Crossgates Mall, 145 of those arrests were made by the RID Investigators. Additionally, RID Investigators were responsible for making 21 arrests that involved juveniles.





Some arrests outside of “routine shoplifting incidents” made by RID Investigators to note:

**January 4, 2023:** A 23-year-old male habitual shoplifter/burglar was arrested following an investigation into numerous shoplifting incidents by the subject who was formally banned from the mall. The subject was captured after a vehicle stop which resulted in a brief foot pursuit and resisting arrest incident. The subject was charged with felony Grand Larceny 3rd and several other penal law misdemeanors.

**March 29, 2023:** A 58-year-old male was arrested for criminal possession of a weapon 4th and menacing 2nd following an argument between two parties where a Taser was allegedly displayed by the arrested party.

**April 28, 2023:** A 24-year-old male was arrested for felony assault and several other penal law charges following an investigation into a domestic violence incident where a store employee was the victim of domestic violence inside of a business in the mall.

**May 12, 2023:** Report that somebody had stolen a set of keys from within the mall and the vehicle associated with the keys was subsequently stolen. The NYSP located the stolen vehicle the following day and the driver of the vehicle, a 58-year-old male, was arrested for felony grand larceny 3rd.

**July 21, 2023:** Subsequent to a shoplifting investigation, a 29-year-old female was arrested on a warrant as a fugitive from justice out of the State of Florida. The subject was remanded to the Albany County Jail pending extradition hearings.

**August 14, 2023:** A 30-year-old male was arrested for felony grand larceny and felony criminal possession of stolen property for possessing forged instruments and opening fraudulent accounts in a business in the mall.

**September 10, 2023:** A RID Investigator attempted to make a vehicle stop on a vehicle that was allegedly involved in a shoplifting incident at the mall and the vehicle fled the area. A 35-year-old male and a 40-year-old female were later arrested on arrest warrants in regards to this incident for two felony and three misdemeanor penal law offenses each.

**November 25, 2023:** A 28-year-old male was arrested following a shoplifting incident where the suspect fled in a motor vehicle, which resulted in a pursuit and subsequent arrest in the City of Albany.

## CRIMINAL INVESTIGATION UNIT

In 2023 the CIU saw additional residential burglaries that appear to be specifically targeted toward people of Asian, Indian, or Eastern European descent. The Guilderland Police responded to the report of shots fired at the Homewood Suites/Hilton Hotel. The Guilderland Police was assisted by several local agencies which ended with the arrest of a local man.

The Criminal Investigation Unit handles a wide variety of cases within the police department. Members of the CIU carry a caseload, work on assigned tasks and assist the patrol unit when needed but they primarily handle felony cases. The CIU is supervised by a First Sergeant and has 4 investigators assigned to the unit. In 2023, Officer Christopher Oades was promoted to investigator after doing an excellent job assisting the CIU in his 2022 temporary assignment. Investigator Oades will handle the departments outstanding warrants, carry a caseload, process crime scenes and take on call time. The functions of the CIU are distributed among the members in the unit. Some of the CIU's other functions are crime scene technicians, evidence and property room, accident investigation, photo arrays, pistol permits, employee background checks, peddlers permit

backgrounds, arresting people on outstanding warrants/administratively processing warrants, professional standard investigations, drug investigations, death investigations and criminal investigations.

The CIU works closely with other agencies to have a successful conclusion to cases assigned to the unit. The agencies the CIU typically works with are the ATF, United States Postal Service, DEA, United States

Secret Service, FBI, Homeland Security, New York State Police, New York State Narcotics Enforcement, Probation/Parole, Capital Region Crime Analysis Center, and other area police agencies. In

addition, the CIU works emergency scenes within the Town of Guilderland with town fire departments and Guilderland Emergency Medical Services.

The CIU would like to remind everyone that Identity theft is still a major issue for police departments all over the nation. Take care to help keep your information private, don't open emails from people or companies you are not familiar with and only use reputable web sites. When shopping on-line, be sure to check that purchases are being made through secure web sites. When in doubt call companies directly.



If you find yourself to be a victim of identity theft, run a credit report and flag your credit to protect against future identity theft. File reports directly to institutions where your identity was used without your authorization. Most financial institutions will require you to file a report with your local police department. The Police will review your case, ask for supporting documentation and try to identify a suspect. Suspect identification can be difficult when purchases are made over the internet and in different states/countries. Victims of identity theft should also report it to the Federal Trade Commission. This can be done on-line at [www.ftc.gov](http://www.ftc.gov) and then follow the prompts. The best way to prevent identity theft is to protect all your personal information and be proactive by actively monitoring your credit report for any unauthorized activity.

Additional financial fraud/scams are occurring using a variety of methods. Calls for winning the lottery, a family member being arrested, cashing checks sent to you where you keep a portion of the money, your computer being compromised are just a few of the fraudulent incidents. Frequently the victims are asked to purchase gift cards and send the numbers to the caller for payment. This is fraud and reputable companies won't ask for payment this way. Further, reputable companies won't ask you to send cash through the mail, send people to your house to take you

to the bank to withdraw funds, send people to your house to pick up cash payments or wire cash to them to pay charges. Contact your local police department and ask questions if you receive a call you believe to be a scam. Research the company to see if there are other complaints prior to sending out any money. Contact the police department to report this type of fraud whether or not you have been a victim. Internet based crimes should also be reported to the FBI Internet Crime Complaint Center by visiting [www.IC3.gov](http://www.IC3.gov).

The Guilderland Police Department and the New York State Police are asking the community for assistance in generating leads in the 2014 homicide of the Chen family on Western Ave. This case remains open and anyone that has any information that may help solve this case should call the CIU or the New York State Police at 518-783-3212 or email [crimetip@troopers.ny.gov](mailto:crimetip@troopers.ny.gov).

The CIU continues to work the 1995 unsolved homicide of Wayne Price, who lived on Church Rd. in the Town of Guilderland, with the assistance of the Albany County District Attorney's Office. ### **2023 Notable CIU cases:**

**In January, February, March, September and December** the CIU investigated reports of residential burglaries. These burglaries appear to be specifically targeted toward people of Asian, Indian, or Eastern European descent. Often the victims are small business owners, the locations are surveilled and the burglaries occur when the residents are at work. The CIU investigated 5 residential burglaries in 2023 that fit this pattern. The CIU coordinated with the Capital District Crime Analysis Center, the New York State Intelligence Center, and with several local, state, and out-of-state law enforcement agencies to assist with the investigations. These cases along with similar cases from prior years remain unsolved and are still active.

All residents are encouraged to remain vigilant and report suspicious activity including suspicious deliveries, suspicious people and suspicious vehicles. It is recommended that homeowners take steps to secure your valuables. Items of value should be secured in a reinforcement-mounted safe (not portable) and if a safe is unavailable hide items in a non-obvious location. In addition, homeowners are encouraged to keep photos of jewelry or other valuables on hand in the event items are lost or stolen. This could help with potentially locating items.

**In May** the CIU investigated a report filed by the family of a man that had been missing for 2 years. The man was originally living in Guilderland and was last seen in Massachusetts. A lengthy investigation was conducted including securing dental records, collecting DNA samples from family members and opening up a case with the National Missing and Unidentified Person Systems. The man was located living on the streets of Massachusetts after he contacted a family member.


**In August** the Guilderland Police responded to Brandywine Apartments for a domestic disturbance/stabbing with potentially life-threatening injuries. Officers discovered two victims had been stabbed by a family member and they were transported to Albany Medical Center for treatment. The family member/suspect had barricaded himself in the apartment. The investigation revealed the suspect may have injured himself and the New York State Police SORT Team was called in to assist with making contact with the suspect. The suspect eventually

surrendered, was taken to Albany Medical Center for treatment and returned to the Guilderland Police Station for arrest. The suspect was arrested for Attempted Murder, Assault 2<sup>nd</sup> and Criminal Possession of a Weapon 2<sup>nd</sup> and arraigned in Guilderland Town Court. The suspect was remanded to Albany County Correctional Facility; orders of protection were issued for the victims and the case was transferred to Albany County Court. The Guilderland Police were assisted on scene by area police agencies.

**In September** the Guilderland Police responded to the report of shots fired at the Homewood Suites/Hilton Hotel. Area agencies assisted with this incident and the man was taken in custody by a combined tactical team. The CIU was tasked with interviewing witnesses, processing the crime scene and securing evidence. The investigation revealed the suspect fired several rounds from two separate handguns through the window, walls and door of his hotel room which entered adjacent rooms, the hallway and went through a window facing outside. The suspect was arrested, arraigned by a Guilderland Town Judge and sent to the Albany County Correctional Facility. The suspect has been indicted by the Albany County District Attorney's Office and is currently out on bail pending the final disposition of this case.

**In October** the Guilderland Police Department received complaints from neighbors that prostitution was happening in a residence on Johnston Rd. The CIU opened an investigation which revealed several girls were using a residence on Johnston Rd for sexual activities. The residence was surveilled for a period of time and vehicle and traffic stops were conducted by members of patrol which confirmed the above allegations. A search warrant was applied for and granted by a Guilderland Town Judge. The warrant was executed, evidence was collected and a female was arrested. The person renting this home is still under investigation and this case is pending further court action.

**In November** the CIU investigated the report of employee theft from Pearl Grant Richman's exceeding \$70,000.00. The investigation revealed the bookkeeper diverted company funds to pay for personal items and services. The suspect was arrested, charged with Grand Larceny 2<sup>nd</sup> and the case was transferred to Albany County Court. The disposition of this case is still pending.




## FIRE INVESTIGATION

The Town of Guilderland Fire Investigation team was formed in 1977 and as of 2023 is comprised of police officers and volunteer fire fighters who live and work in the Town of Guilderland. The team is led by Police Chief Daniel McNally.

In 2023, the Town of Guilderland Fire Investigation Team responded to 17 fires. A total of 161 hours were devoted to investigating these fires.

Investigating a fire is an arduous task. There are many factors that come in to play when investigating a fire scene that can help to determine the cause classification of a fire. Fires are classified by four categories; Accidental, Natural, Incendiary and Undetermined.

Classification is completed after analyzing all of the facts and applying the information obtained to select one of the four classifications. Knowing the cause classification is important as it can lead to the prevention of future fires. For example; an accidental fire occurs in an appliance, a toaster oven. It's determined that the toaster oven has a bad electrical connection that could become loose, posing an electrical shock and burn hazard. Natural fire is for a fire that is ignited without any human involvement, such as lightning, wind and earthquakes. Incendiary fires are intentionally set by a person in an area or under situations where and when there should not be a fire. Undetermined are fires that have been investigated however there may not be an acceptable



level certainty of what caused the fire, such as what was the ignition source or what was the first fuel ignited. A good example of this would be the total consumption of a structure that left little or no evidence as to what happened, could prompt a fire to be classified as undetermined. Of course, as more information is learned upon further investigation, the undetermined fire classification can be reclassified as more information is discovered.



## ANIMAL CONTROL

The Guilderland Animal Shelter temporarily houses dogs and cats that are left unattended, stray or found within the Town of Guilderland. After a period of time, if an owner cannot be located, the shelter will commence an adoption process.

There are two animal control officers who are responsible for;

- Enforcing laws and ordinances in the town concerning animals,
- Supervising the care and protection of animals impounded,
- Seizing and impounding stray and dangerous animals,
- Issuing tickets in accordance with provisions of law,
- Investigating and take corrective action on complaints concerning animals running at large and unlicensed dogs,
- Maintaining records relating to the investigation of animal complaints,
- Impounding unlicensed animals running at large,
- Securing uncontrollable animals,
- Investigating reports of cruelty to animals,
- Testifying in court, as required,
- Enforcing quarantine laws and ordinances applicable to dogs,
- Picking up and disposing of deceased animals,
- Transporting sick or injured animals to a veterinarian for treatment,
- Maintaining records and information regarding the licensing of dogs and other animals in accordance with the provisions of applicable laws,
- Investigating complaints regarding stray, dangerous and/or injured animals,
- Assisting with the maintenance and operation of the animal shelter and any animal in their care,
- Assisting with animal adoptions and related paperwork,
- Assisting with animal adoption clinics,
- Conducting animal redemptions.




### Officer Adam Myers
