Brief Description of Proposed Action (include purpose or need): The Apex at Crossgates will provide 222 Class A rental units, including 192 apartments over a first level parking garage, plus 30 townhomes with private garages. In addition the site includes a 6,500 square foot clubhouse, outdoor pool, and recreation space. The Apex will have a lighted and landscaped walking path to the adjacent Crossgates Mall, as well as sidewalk connections to the nearby CDTA bus stop and to Western Avenue. The 222 residential units will remain consistent with the previously approved site plan and the amount of surface parking will be reduced because some parking will be moved within the residential buildings. It should be noted that with this plan that the additional 90 units, designated as future development, will be permanently abandoned. The parking count will be slightly less than was previously approved while reducing the amount of impervious cover on the project site. The total impervious area on the project site will be reduced by over 10,000 sf as part of the proposed site plan modifications.
