Incomplete or illegible applications, applications submitted without the permit fee, and applications submitted without required certificates of insurance will not be processed.

* Sections 57 and 220 of the New York State Workers' Compensation Law provide that the Town of Guilderland shall not issue any permit unless proof of workers' compensation and disability benefits insurance coverage (or proof exemption) is produced. The ACORD form commonly used to show liability, auto and other insurance cannot be used for Workers Compensation or Disability Insurance. Questions relating to either workers' compensation or disability benefits coverage can be directed to the State of New York Workers' Compensation Board, Bureau of Compliance at (877) 632-4996 (Monday through Friday – 8:30 AM to 4:30 PM).

Application Submittals

I understand and acknowledge the Permittee assumes all risks related to this permit and shall be solely responsible and answerable in damages for all accidents or injuries to person or property, and hereby covenants and agrees to indemnify and keep harmless the People of the State of New York; Town of Guilderland; their officers and employees; from any and all claims, suits, losses, damage or injury to person or property of whatsoever kind or nature, whether direct or indirect, arising out of the operation of this Permit, or the carelessness, negligence or improper conduct of the Permittee or any servant, agent or employee thereof.

The Town of Guilderland shall not be responsible for property damage or personal injury to the Permittee, or any person upon the premises at the invitation of the Permittee.

The Permittee hereby waives any and all claims for compensation for any and all loss or damage sustained by reason or any interference by any public agency or official in the operation of this Permit; any such interference shall not relieve the Permittee from any obligation hereunder.
