

The Guilderland Police Department began in 1972 with six officers, four telecommunicators, and one administrative assistant. The goal was simple; to provide community policing objectives to our town. With the contributions and hard work of many members sworn and unsworn, retired and current, the Guilderland Police Department evolved into one of the best police departments in the Capital District.

Today we have 42 sworn police officers, 12 telecommunicators and three administrative staff members. Our department has a Patrol Division, Criminal Investigation Division, Community Service Unit, Retail Interdiction Detail, School Resource Officer Program, Special Reaction Team, Fire Investigation Unit, Accident Reconstruction Unit, K-9 Unit, Police Explorer/Cadet Program, Training Division, Communications Division, Animal Control Unit and a Traffic Safety Unit.

ACCREDITATION

ACCREDITED AGENC

Since 2009 the Guilderland Police
Department has been an accredited agency
through the New York State Law
Enforcement Accreditation Program. Being
an accredited agency is something that the
department is proud of as only
approximately one third of agencies across
the state are accredited. The agency works
tirelessly to comply with the State's 110

standards to ensure that the agency is partaking in best contemporary practices and operating on sound policy in order to best serve the public. The New York State Division of Criminal Justice Services describes accreditation as a progressive and

contemporary way of helping police agencies evaluate and improve their overall performance. It provides formal recognition that an organization meets or exceeds general expectations of quality in the field. Accreditation acknowledges the implementation of policies that are conceptually sound and operationally effective. The New York State program became operational in 1989 and encompasses four principle goals:

- To increase the effectiveness and efficiency of law enforcement agencies utilizing existing personnel, equipment and facilities to the extent possible;
- To promote increased cooperation and coordination among law enforcement agencies and other agencies of the criminal justice services;

- 3. To ensure the appropriate training of law enforcement personnel; and
- 4. To promote public confidence in law enforcement agencies.

The reaccreditation process occurs every five years and the agency was most recently reaccredited in July 2019. The agency utilizes sworn personnel to maintain the accreditation program. Sergeant Egnor

is the Program Manager and Patrolman McCormick is the Assistant Program Manager.

TRAINING

In 2022, the Guilderland Police
Department transitioned to a new duty
handgun. The Glock G45 9mm replaced the
Smith and Wesson M&P 45 that officers
carried for over ten years. With the
implementation of a new handgun,
extensive training was conducted in the
use, care, and maintenance of the handgun.
In addition, the department continued the
use of scenario-based training in the use of
de-escalation tactics as well as the use of
less lethal force. Officers utilized several
different training locations to train in active
shooter response and tactical response.

One officer from the Guilderland Police Department successfully completed training and is now certified as a Drug Recognition Expert (DRE). The DRE officer will be instrumental in evaluating and identifying individuals who are driving while impaired by the use of drugs which is vital in light of the legalization of cannabis.

In addition to adding a DRE, the department sent four officers to training to become certified general topics instructors, one of which was certified as a Standardized Field Sobriety Test instructor and Breath Analysis Operator instructor in an effort to enhance our department's ability to effectively enforce impaired driving. In addition to these officers receiving this training, several patrol officers attended training in the recognition and apprehension of impaired drivers.

Also in 2022, two officers attended Crisis Intervention Team training hosted by the Albany County Department of Mental Health. This specialized training will aid our patrol officers in the response to individuals in crisis. These two officers join five other officers that have received this training in the past.





COMMUNICATIONS

The Guilderland Police Department Communications Division is staffed with certified E 911 telecommunicators. Enhanced 911 means that when you call



911, the address you are calling from is automatically displayed on the Telecommunicator's screen. This is crucial in the event a person becomes unconscious before giving you the location or a crime in progress prevents the caller from giving the address. The Division is a 24-hour operation and is a vital link to the residents and businesses in this town to the emergency personnel in the field.

Currently, the communications division is staffed with 11 telecommunicators and 1 supervisor. Each telecommunicator is trained in Emergency Medical Dispatch (EMD), CPR and AED. Every two years, they recertify to keep up with their training in those fields. National Telecommunicators Week is recognized every year in April; Communities and emergency communications centers honor those

telecommunicators that help save lives in times of personal or a national crisis. New York State continues to recognize telecommunicators as First Responders.

The Town of Guilderland Emergency
Communications Service that includes
Police, Fire and EMS has migrated to the
Albany County 800MHz trunked Radio
System. This system allows seamless
communications with all Albany County
Emergency Responder agencies as well as
local schools and school buses; including
Emergency Responder Communications
with Saratoga, Rensselaer and Schenectady
Counties.

The system employs the latest Radio technology and has proven to be a great public safety asset allowing Radio Interoperability amongst all agencies that once all operated independently.

This year Telecommunicators received over 35,000 911 calls for service. Those 911 calls include, non-emergency calls and transferred cellular 911 calls. 26,146 calls were taken for police, 7,047 emergency medical services (EMS), and fire calls were received for service. This brings the total to 33,193 calls for service this year.

PATROL



In 2022, the patrol division responded to 18,898 calls for service. Twenty-three of those calls for service were related to opioid overdoses. In two of those calls, patrol officers successfully administered Narcan to the patient. All of the patrol officers in the Guilderland Police Department are trained in the use of Narcan and they each carry one dose of Narcan.

The Guilderland Police Department welcomed one new officer this year; MaryKate Montemagno was a lateral transfer from the Troy Police Department. Additionally, two new vehicles were added to the patrol fleet of vehicles. The vehicles are 2022 Ford Explorers which replaced two out of the last three Ford Taurus' that were left in the fleet. These vehicles and all future vehicles added to the patrol fleet are black with red and white graphics which is a change over from the current white Explorers with red and black graphics.

Members of the patrol division work hard every day to provide kind, courteous, and professional service to the Town of Guilderland. They also work hard to keep the town residents and those who visit safe from harm. In October of 2022, Officers Brandon Carkner and Tylor Stevens recovered a loaded handgun that was illegally possessed by a juvenile from the City of Albany following an interview with the individual regarding suspicious activity that they observed.

COMMUNITY SERVICE

The focus of the Community Service Unit in 2022 was the celebration of the Guilderland Police Department's 50th Anniversary. The Guilderland Police began patrolling the streets of Guilderland in 1972 with a small police force consisting of 6 police officers. As the Town has grown so has the Guilderland Police Department, which now has 42 sworn members. To commemorate 50 years of service to our community, the Guilderland Police Department held two special events. The first event took place in June at DiCaprio Park and the second was a combined event with National Night Out, our annual community celebration in August at Tawasentha Park. Members of the Guilderland Police Department and some of the original Officers came together with the community to celebrate 50 years of dedicated service by the men and women of the Guilderland Police.

To mark this milestone, the Guilderland Police Department partnered with Public Safety Insignia producing an anniversary



badge, patch and challenge coin. Members of our department during the anniversary year proudly wore the 50th Anniversary badge and patch.

Challenge coins are available to the public for purchase at a cost of \$5.00 each while supply lasts.
Payment is accepted by cash, check or money order in the police Chief's office Monday-Friday 9am-4pm.

The Guilderland Police Community Service Unit (CSU) is staffed with a juvenile officer, a school resource officer (SRO) and an investigator that works in the CIU as well. All officers are certified juvenile officers that have extensive training in juvenile law, sexual/child abuse and missing person's investigations. Chief McNally, seeing a need for an SRO at Farnsworth Middle School, partnered with The Guilderland School District and funded an additional SRO for the end of the 2022 school year. An interview committee consisting of members of the Guilderland Police Department, Guilderland Central School administrators, a school board member and a student, interviewed interested candidates and Officer

students and staff

by maintaining school safety and security. In addition, the CSU officers provide the Guilderland School District with Drug Abuse Resistance Education (D.A.R.E.) and various instruction on topics like health, forensics and public policy. The CSU assists the patrol division with juvenile related offenses and felony juvenile cases. The CSU works to identify and resolve community problems

through proven law enforcement programs such as Rape Aggression Defense Program (R.A.D.), Drug Take Back Day and Coffee with a Cop. The CSU participates in community partnership events like local food drives and Dick's Sporting Goods Shop with a Cop. Other services provided to the community by the CSU include fraud prevention, provides CRASE training and the installation of child passenger safety seats. The CSU coordinates the set-up of National Night Out and the Guilderland Police Department's educational display at the Altamont Fair. Officers in the CSU attend trainings related to forensic interviewing of children, missing and abducted children, child abuse and New York State raise the age laws and updates.

The Explorer program is a career-oriented program that allows the youth of our community between the ages of 14-21 an opportunity to explore law enforcement by working closely with members of the Guilderland Police Department.

The CSU oversees the Guilderland Explorer Post, which entered its 30th year. The post meets twice a month for training and provides assistance with community programs sponsored by the CSU. During the year, explorers receive training in police exercises and compete with other area posts. The training provides Explorers with skills they will use in the future as potential police officer candidates and community leaders. The Explorers attend an Explorer Academy, which is a weeklong multi-phased police academy where they can work alongside and compete against regional explorer programs. The Explorer program has been a valuable tool to reach out to and work with the youth of our community.







Officer Stevens has been a member of the department since 2006, and became the department's newest canine handler in 2021 with the addition of K9 Boreas, who is

now approximately 2.5 years old. The Guilderland Police Canine Team train regularly with the Capital District Canine Training Group to stay proficient in the designated disciplines. Officer Stevens and K9 Boreas also attended and completed several outside training seminars and numerous training events put on by NYS Department of Homeland Security and Emergency Services and the FBI. In the year of 2022, Officer Stevens and K9 Boreas were utilized numerous times for call-outs to assist surrounding agencies for a variety of calls for service. These calls for service





included numerous search warrants, suspicious packages, bomb threats and several community events. Officer Stevens and K9 Boreas also assisted members of the Guilderland Police department on numerous calls for service including search warrants, tracking, missing persons, crimes in progress, and other investigations. Officer Stevens and K9 Boreas have been to several schools in the GCSD to speak with students on various topics and have attended several D.A.R.E graduations. The Canine team enjoy working and meeting with the community and can been seen at our local events such as the Altamont Fair. National Night Out, the Department's 50th Anniversary, and others. Officer Stevens and K9 Boreas love to speak to members of the community and answer all questions regarding their training and background and greatly appreciate the support from the community.

RETAIL INTERDICTION DETAIL

The Town of Guilderland is home to the 5th largest shopping mall in New York State, Crossgates Mall. The Guilderland Police Department maintains a substation in the mall for handling complaints and arrests at the mall and on the eastern end of town. In 2018, the department initiated the Retail Interdiction Detail (R.I.D.) at the mall in anticipation of the holiday shopping season and due to several instances of public disorder. The detail is composed of two uniformed "RID" Investigators that are assigned there. The officers work "flex shifts" that coincide with the mall's hours of operation. RID Investigators address issues related to theft from stores as well as disruptive or other criminal behavior that takes place within the mall.

The RID Investigators team up with Crossgates Mall Security and Management, as well as loss prevention personnel from various stores to form a unified effort in reducing thefts. In 2021, the mall welcomed Albany 518 Snug to its anti-crime efforts and those efforts continued through 2022. Albany 518 Snug deploys outreach workers in the mall to assist with identifying and interrupting potentially violent situations. In 2022, RID Investigators handled 1,489 documented calls for service. In 2022, there were a total of 179 adult arrests made at Crossgates Mall, 145 of those arrests were made by the RID Investigators. Additionally, RID Investigators were responsible for making 12 arrests that involved juveniles.

Some arrests outside of "routine shoplifting incidents" made by RID Investigators to note:

February 19, 2022: (3) juveniles were arrested for Menacing 2nd following reports that the juveniles displayed knives to a business employee within Crossgates Mall placing that employee in fear. The juveniles were located shortly thereafter inside of Crossgates Mall, they were detained, knives were recovered, they were arrested and released to legal guardians.

May 6, 2022: Subsequent to a shoplifting investigation at a business within Crossgates Mall, a 27-year-old male was arrested by RID Investigators as a fugitive from justice after discovering that there was an active arrest warrant for him out of San Francisco County, California. The subject was arraigned and remanded to jail awaiting extradition.

May 16, 2022: Subsequent to a shoplifting investigation at a business within Crossgates Mall, a 52-year-old male was arrested by RID Investigators as a fugitive from justice after discovering that there was an active arrest warrant for him out of Fulton County, Georgia. The subject was arraigned and remanded to jail awaiting extradition.

October 18, 2022: RID Investigators received a report from a business within Crossgates Mall that a bag was located on the floor of the business and the bag contained a loaded handgun. A 19-year-old male was arrested shortly thereafter by RID Investigators for Criminal Possession of a Weapon 2nd for illegally possessing a loaded firearm and Criminal Possession of a Weapon in a Restricted Area. The subject was arraigned and released to the supervision of probation.

December 28, 2022: Subsequent to a shoplifting investigation at a business within Crossgates Mall, a 60-year-old male was arrested by RID Investigators for Criminal Possession of a Controlled Substance 3rd (class "B" felony) and criminal Possession of a Controlled Substance 4th (class "C" felony) after the subject was found to be in possession of crack cocaine and other narcotic drugs. The subject was arraigned and remanded to jail.

Members of the RID often network and develop good working relationships with employees of businesses within Crossgates Mall. This promotes a team atmosphere to combat and deter retail crimes. RID Investigators and business employees also team together to partake in community outreach initiatives. In 2022, one of the RID Investigators was recognized for his efforts in a ceremony held at Town Hall.

In December 2022, Officer Strock, of the Retail Interdiction Detail at Crossgates Mall, partnered with Gap Inc. who created hope bags for children entering foster care. Over 100 bags were assembled by members of the Gap Inc. team and donated to Berkshire Farms Center and Services for Youth, as well as SNUG of Albany, a program designed to assist with at risk youth. During the partnership event, Officer Strock was honored by Gap Inc. Asset Protection with the Quarter 3 2022 Award for outstanding service to the retail community.

CRIMINAL INVESTIGATION DIVISION

The Criminal Investigation Unit handles a wide variety of cases within the Police Department. Members of the CIU carry a caseload, work on assigned tasks and assist the Patrol Unit when needed. The CIU primarily handles felony cases. The CIU is supervised by a First Sergeant and has 3 investigators assigned to the unit. In 2022 additional help was needed in the CIU to handle outstanding warrants due to justice reform and Officer Chris Oades was chosen for this task. In addition, Officer Oades handles a caseload and assists with on-call time. The functions of the CIU are distributed among the members in the unit. Some of the CIU's other functions are crime scene technicians, evidence and property room, accident investigation, photo arrays, pistol permits, employee background checks, peddlers permit backgrounds, administratively processing warrants/warrant investigations, professional standard investigations, drug investigations, death investigations and criminal investigations.

The CIU works closely with other agencies to have a successful conclusion to cases assigned to the unit. The agencies the CIU typically works with are the ATF, United States Postal Service, DEA, United States Secret Service, FBI, Homeland Security, New York State Police, New York State Narcotics Enforcement, Probation/Parole, Capital Region Crime Analysis Center, and other area police agencies. In addition, the CIU works emergency scenes within the Town

of Guilderland with town fire departments, ambulance service and paramedics.

The CIU would like to remind everyone that Identity theft is still a major issue for police departments all over the nation. Take care to help keep your information private, don't open emails from people or companies you are not familiar with and only use reputable web sites. When shopping on-line, be sure to check that purchases are being made through secure web sites. When in doubt call companies directly.

If you find yourself to be a victim of identity theft, run a credit report and flag your credit to protect against future identity theft. File reports directly to institutions where your identity was used without your authorization. Most financial institutions will require you to file a report with your local police department. The Police will review your case, ask for supporting documentation and try to identify a suspect. Suspect identification can be difficult when purchases are made over the internet and in different states/countries. Victims of identity theft should also report it to the Federal Trade Commission. This can be done on-line at www.ftc.gov and then follow the prompts. The best way to prevent identity theft is to protect all your personal information and be proactive by actively monitoring your credit report for any unauthorized activity.

Additional financial fraud/scams are occurring using a variety of methods. Calls for winning the lottery, a family member being arrested, cashing checks sent to you where you keep a portion of the money, your computer being compromised are just a few of the fraudulent incidents. Frequently the victims are asked to purchase gift cards and send the numbers to the caller for payment. This is fraud and reputable companies won't ask for payment this way. Further, reputable companies

won't ask you to send cash through the mail or wire cash to them to pay charges.

Contact your local police department and ask questions if you receive a call you believe to be a scam. Research the company to see if there are other complaints prior to sending out any money. Contact the police department to report this type of fraud whether or not you have been a victim. Internet based crimes should also be reported to the FBI Internet Crime Complaint Center by visiting www.ic3.gov

The homicide of the Chen family on Western Ave remains open and anyone that has any information that may help solve this case should call the CIU or the New York State Police at 518-783-3212 or www.troopers.ny.gov

The 1995 unsolved homicide of Wayne Price who lived on Church Rd. in the Town of Guilderland will be reopened in 2023 with the assistance of the Albany County District Attorney's Office. 2022 Notable CIU Cases

In January, patrol responded to a reported home invasion where the two suspects were armed with a stolen semi-automatic pistol and a ghost assault rifle. The residents fought with the two suspects during which the suspects were disarmed and were held until the arrival of police. Both suspects were taken into custody charged with Robbery 1st, Criminal Possession of a Weapon 2nd, Burglary 1st, Menacing 2nd, and Petit Larceny. Arrested was Jorge Rosario age 51 and Alexander Madera age 18. The CIU initiated a lengthy investigation and determined the residence was specifically targeted. Due to nature of the firearms involved, ATF joined the investigation and both of the suspects' cases were transferred to Federal Court. The case is still pending in court.

In March, Raquan Dyson was arrested for Rape 2nd and Criminal Sexual Act 2nd after he had sexual intercourse with a juvenile female that he met over social media that was less than 15 years of age. Three additional juvenile female victims were identified which led to the arrest of

Dyson for sending and receiving pornographic images for those victims. Dyson, who is 29 years of age, portrayed himself as a juvenile male over social media, contacted potential victims and struck up conversations with them. Dyson's case is pending prosecution in Albany County Court.

Also in March, the CIU started an investigation into the theft of \$10,000 from Trustco Bank. The investigation revealed an employee was responsible for this theft. The employee was questioned by investigators and admitted taking the money. The employee was arrested and the money was recovered. This case was sent to Albany County Court for prosecution and a plea agreement was reached which included full restitution to Trustco Bank.

In April, the CIU investigated the exchange of gunfire between two groups of juveniles outside Crossgates Mall in the Best Buy parking lot, which resulted in a bullet wound to the hand of a juvenile female patron. The CIU identified several juveniles involved in this incident and the patron struck by the bullet was an unintended victim. The investigation led to the identification and arrest of a juvenile male and juvenile female for this shooting. Their cases were transferred to Albany County Youth Part Court for prosecution and are still pending a resolution.

In June, the CIU investigated a case of unlawful surveillance at Macy's Crossgates Mall. A female employee reported to loss prevention that an adult male co-worker placed his phone in a position to view/video/photograph under her skirt. Macy's Loss Prevention viewed surveillance footage and could see the co-worker appeared to be recording under the female's skirt on numerous occasions. The CIU applied for a search warrant to seize and search the suspect's cell phone, which was granted. The suspect was arrested after reviewing information returned from the search of his phone. The case was transferred to Guilderland Town Court and is pending a resolution.

In July, the CIU investigated five reports involving the theft of vehicles and recovery of stolen vehicles in the Town of Guilderland. At the same time, the CIU assisted the patrol division in the investigation of several larcenies from vehicles in the Town of Guilderland. The investigation revealed five suspects, who recently moved into the town, were responsible for the above crimes. The three juvenile males and two adult females lived in the immediate area of the crimes. All the vehicles were located and returned to their owners. A search warrant for the suspects' residence was obtained and during the execution of the search warrant, additional stolen property was located and the suspects were arrested. Further investigation revealed some of the credit cards taken in the larceny from vehicles had been used to purchase merchandise from various stores. The suspects' cases are still pending in court.


In October, the CIU assisted the United States Postal Service and other federal agencies with a search warrant for a residence on Willey St. The USPS discovered illegal drugs were being sent

It is recommended that homeowners take steps to secure their valuables. Items of value should be secured in a reinforcement-mounted safe (not portable) and if a safe is unavailable hide items in a non-obvious location. In addition, homeowners are encouraged to keep photos of jewelry or other valuables on hand in the event items are lost or stolen. This could help with potentially locating items.

to that location through the mail and suspects were developed. During the execution of the search warrant, illegal drugs were recovered. The USPS arrested a resident at the home for possession with intent to distribute methamphetamine. Prosecution of this case is in the Federal Court System.

In November, the Bureau of Alcohol Tobacco and Firearms (ATF) and the Guilderland Police arrested Jason Seminary for being a convicted felon in possession of a firearm and ammunition, which was recovered from two separate locations during the death investigation of Kentish Bennett. Seminary appeared in Federal Court for arraignment and ordered held in Federal custody pending the outcome of his case.

In December, the CIU investigated reports of residential burglaries. These burglaries appear to be specifically targeted toward people of Asian, Indian, or Eastern European descent and often the victims are small business owners. The CIU has coordinated with numerous other law enforcement agencies and determined these cases are linked to organized groups that specifically target such residences. These investigations are still ongoing.



FIRE INVESTIGATION


The Town of Guilderland Fire Investigation team was formed in 1977 and as of 2022 is comprised of Guilderland Town Police Officers (current and retired), Chief Building and Zoning Inspector, Chief Fire Inspector, Code Enforcement Officer and an electrician. The team is led by Chief Daniel McNally.


Technology has created some challenges and safety risks for first responders and fire investigators. Car fires for example are ever more challenging than ever, especially hybrid vehicle fires. The National Transportation Safety Board (NTSB) investigated three electric vehicle crashes resulting in post-crash fires and one non-crash fire involving an electric vehicle, all of which illustrate the risks to emergency responders posed by the vehicles' high-voltage lithium-ion batteries. The NTSB also examined national and international standards established to maximize the safety of electric vehicles. Particular attention was given to the emergency guidance documents supplied by vehicle manufacturers to mitigate the safety risks to first responders and fire investigators who deal with electric vehicle crashes and high-voltage lithium-ion battery fires.

Fires in electric vehicles powered by high-voltage lithium-ion batteries pose the risk of electric shock to emergency responders from exposure to the high-voltage components of a damaged lithium-ion battery. A further risk is that damaged cells in the battery can experience uncontrolled increases in temperature and pressure (thermal runaway), which can lead to hazards such as battery reignition/fire. The risks of electric shock and battery reignition/fire arise from the "stranded" energy that remains in a damaged battery. Extra caution must be taken for fire investigators while investigating vehicle fires.



In 2022, the Town of Guilderland Fire Investigation Team responded to 16 fires, eleven were structure fires, three were car fires and two were outdoor fires. Eleven structure fires were determined as accidental, three incendiary and two undetermined. One juvenile male was arrested and charged with Arson for intentionally setting an outdoor fire. One adult male was arrested for intentionally setting a fire inside of a structure.





ANIMAL CONTROL

The Guilderland Animal Shelter temporarily houses dogs and cats that are left unattended, stray or found within the Town of Guilderland. After a period of time, if an owner cannot be located, the shelter will commence an adoption process.

There are two animal control officers who are responsible for;

- Enforcing laws and ordinances in the town concerning animals,
- Supervising the care and protection of animals impounded,
- Seizing and impounding stray and dangerous animals,
- Issuing tickets in accordance with provisions of law,
- Investigating and take corrective action on complaints concerning animals running at large and unlicensed dogs,
- Maintaining records relating to the investigation of animal complaints,
- Impounding unlicensed animals running at large,
- Securing uncontrollable animals,
- Investigating reports of cruelty to animals,
- Testifying in court, as required,

- Enforcing quarantine laws and ordinances applicable to dogs,
- Picking up and disposing of deceased animals,
- Transporting sick or injured animals to a veterinarian for treatment,
- Maintaining records and information regarding the licensing of dogs and other animals in accordance with the provisions of applicable laws,
- Investigating complaints regarding stray, dangerous and/or injured animals,
- Assisting with the maintenance and operation of the animal shelter and the care of any animal there at,
- Assisting with animal adoptions and related paperwork,
- Assisting with animal adoption clinics,
- Conducting animal redemptions.
